Conditions of Enrolment for Scholarship

Please note, the Scholarship enrolment application must be signed by all parents/guardians of the student.

I/We the undersigned, accept as conditions of Scholarship enrolment that:

(Please tick to acknowledge you have read and accepted each of the statements below.

- Continuation of Scholarship:** I/We understand that the continuation of any Scholarship beyond one year is conditional upon a satisfactory review of the child's educational achievements.
- Participation in School Programme:** I/We the undersigned, undertake as a condition of enrolment that the above-named student will participate in all the activities of the School programme as these reflect the ethos and character of the School.
- Attendance:** I/We agree to support the student to maintain regular attendance. An unanticipated absence for the day will notified to the School by 8.15am. Written notification will be provided for any planned absences and the Principal's permission is sought in writing for extended absences. The School can discontinue attendance of the above-named student in default of this undertaking.
- Fees:** I/We accept that fees are payable in full by the first day of each term but in the case of new students, are payable two weeks before the term starts. Overdue fees will attract a 5% penalty fee and the School reserves the right to request the withdrawal of your child if fees remain unpaid.

Application Fee: A non-refundable fee of \$100 is payable with this application.

Acceptance Fee: The usual Acceptance Fee of \$1,000 is waived for Scholarship candidates.

Bond: Upon offer of a Scholarship, parents are required to pay a \$1000 refundable acceptance bond. This will be refunded in the term after your child leaves Ficino School, less any payments owing. If you withdraw your child without giving the required one terms notice in writing to the Principal, this bond will be forfeited.

Invoices: All invoices issued, covering items such as uniform, trips and events, are payable upon issue. Trip and event fees are non-refundable when a child is absent from school on the day of the trip or event due to sickness or other reasons.

- Notice of Withdrawal:** I/We accept that one term's notice in writing addressed to the Principal is required prior for the withdrawal of a student. Failure to do this will result in the bond being forfeited.
- Uniform:** I/We will ensure that the student will at all times abide by the uniform requirements and hair regulations of the School.
- Conduct:** I/We undertake to uphold the School Values in our dealings with others in the School community, and through our example will ensure our child also abides by the School Values.

ICT Agreement: I/we agree to co-read and co-sign the Student ICT Agreement with my/our child on an annual basis.

Education Outside the Classroom (EOTC) Permission:

- I give permission for my child to participate in walking to events away from the School. The children need to walk with teachers to various events and sporting activities during the school year. These may include swimming lessons at Mt Eden Pools, Church Services at St Barnabas Church, the Cross Country run on Mt Eden, occasional outings to local parks, etc.
- I am aware that any lengthier trips from the School will be notified via a letter/email and it is my responsibility to inform the school if my child does not have permission to attend.
- I understand it is my responsibility to inform and update the School with any medical concerns of which the staff members involved need to be aware.

Permission to Publish: Ficino School will at times publish photographs. Often photographs are taken in such a way to avoid identification of individual students. Nonetheless, from time-to-time teachers and staff would like to use photos, recordings and videos of students (media) in which students can be identified. The purpose of doing so is to record school activities, to celebrate current and past students' successes and promote Ficino School. Exemplary and identifiable pieces of student work are also sometimes published. We use media and student work for recognising achievement and participation through:

- Students' online learning journals (classwork)
- School Newsletter and School website
- School and classroom displays or presentations
- School social media activity
- Advertising and Prospectuses

It is the School's policy that any images for publication are positive depictions of the children.

I give permission for Ficino School to use and publish images of my child and pieces of his/her work for the purposes stated above.

Every effort will be taken to ensure that your privacy is respected. At any time, should there be a mistake (eg human error) or a concern, please contact the School office immediately.

Privacy and Use of Personal Information: Our philosophical principle, to respect all, informs our approach to privacy within the Ficino School community. Personal information is collected only for the intended lawful purpose: to support the delivery of high-quality education. Ficino School needs to collect certain personal information about you and your child, including your contact details, emergency details, health information and academic information relating to your child. In accordance with the School's obligations set out in the Privacy Act 2020, the School will use this information:

- to process an enrolment application for a position at Ficino School
- to provide educational services and the associated school activities
- to care for the physical, social and emotional wellbeing of students
- to maintain the safety of students
- to manage and administer School services
- to process and respond to enquiries or requests
- to contact individuals in the event of an emergency

The information will be available to staff at Ficino School and to members of the Board of Trustees. Please advise the School if you have any concerns about disclosure of any of the information within the School.

Ficino School is sometimes required by law to give information to government departments (e.g. Ministry of Education and Ministry of Health) or other organisations, but your information will not otherwise be disclosed without your consent.

You have the right to request access and/or correct information held by the School about you or your child. Please contact the School Office if any contact or other details need to be changed.
